## ARCHITECTURAL AWARD

If you drive west on Civic Center Drive you are bound to notice a very neat grey and white Victorian house on the north side of the street at Baker. This is the home of Mrs. Henrietta Crowell. She has lived there since 1901, when her family moved from San Juan Capistrano to Santa Ana. She was just two years old.

Mrs. Crowell has continued to keep the house in top condition through the years, while retaining almost all of its historic architectural character. Mrs. Crowell has a very sharp mind and remembers early Santa Ana well. Her parents, Baptiste and Marion Duhart, owned a walnut grove covering 16 city lots from Bristol to Baker. The lots were eventually divided among the 7 children in the family and developed. Henrietta's sister, Mrs. Muccullum, still lives around the corner on Louise Street, on part of the original ranch. Mrs. Crowell remembers when Civic Center Drive was called Hickey Street and, after 1923. Eighth Street She and her family knew everyone who lived in Santa Ana! Mrs. Crowell who likes to garden and work in her well-kept yard, drives herself to the store and leads an active and independent life.

Mrs. Crowell is a resident of the Washington Square neighborhood, and was recently honored in the W.S.N.A. newsletter. Todd Walsh provided the information for both that article and this one. Congratulations to Mrs. Crowell and our thanks to Todd.



## HISTORIC FRENCH PARK GARAGE SALE--NOV. 10

Our neighbors in French Park wilhold an all-neighborhood garage sale in French Park (French at Vance) on November 10th, starting at 9:00 a.m. This event is too good to miss!



Who was Jack Fisher? Those of you who have driven down Flower Street, between Santa Clara and Memory Lane, have seen the familiar sign that says Jack Fisher Park. Located on the north bank of Santiago Creek, the park contains many fine specimen trees and a picturesque log cabin. Dedicated in 1933, the park has changed little within the last 57 years.

Jack Fisher was a much-decorated World War I hero who was born and raised in Santa Ana. He began his overseas service in France, earning a Purple Heart and the French Croix de Guerre with Palm. As a result of his gallant actions at the battle of Belleau Wood, he won a second palm to his Croix de Guerre. He was hospitalized after being wounded in action and received a cluster to his Purple Heart and The Medaille Militaire. The latter was France's highest military decoration.

Jack returned to action and fought in the Battle of Verdun and the Battle of Argonne Forest. Seriously wounded, he was only one of three men to return to the American lines alive. He carried his lieutenant on his back. He was awarded the Distinguished Service Cross and another Palm to his Croix de Guerre. After he recovered, he again returned to the front lines. He received honors for his heroic deeds from many nations. Italy, Belguim, Britain, and France presented him with metals for his courage. In Jack's last battle, he lay on the field for 48 hours, his leg shattered by shrapnel. His stomach and lungs were injured when he was accidently given water contaminated with mustard gas. His chances for survival were slim.

Miraculously, Jack did survive, and returned to the United States on crutches. He studied art and cartooning while in the military hospital in San Francisco and became an artist for the San Francisco Examiner. Returning to Santa Ana in 1927, he worked as a cartoonist and artist for the Santa Ana Register. He devoted many hours to organizing the Santa Ana Chapter of the Disabled American Veterans. After he died on March 1, 1929, the Chapter was renamed in his honor. Jack Fisher Park was dedicated on August 23, 1933, under the auspices of the Jack Fisher Chapter of the Disabled American Veterans.


In 1935 a tree planting program, under the direction of Park Superintendent Dale Griggs was begun in Jack Fisher Park. Of the 24 varieties of eucalyptus trees planted in the park, 14 came directly from New Zealand. Many of these trees are still thriving in the park today. The log cabin, which is approximately thirty years old,

has been used by the Scouts and various civic organizations.

The Fisher Park Neighborhood Association, founded by the homeowners from the adjacent residential areas, is making plans that will improve and enhance the natural beauty of the park. They will be working with the City of Santa Ana to upgrade the grounds and hope at some time in the future they will be able to plant a botanical garden. As a first step, they are asking that the park be designated as a passive park. That system has been successful in French Park, which was declared a passive park several years ago. Increased park security, additional lighting, a sollution to parking problems, and improved restrooms are some of the goals the Fisher Park Neighborhood Association is exploring. S. A. H. P. S. lends its support to these efforts and wishes the Fisher Park Neighborhood Association much success toward meeting their goals.



# GRAND REOPENING OF THE SANTORA BUILDING

One of the most beautiful and historic commercial buildings in Orange County, the Santora Building, located on the corner of Broadway and Second Street in the Downtown Santa Ana Historic District, was recently reopened for business

after undergoing an extensive restoration process.

The Orange County Historical Society, City of Santa Ana, and Santora Partners were hosts for the grand reopening party on September 6th. Using the theme of Daniger's Tea Room, the decorations featured fresh flowers and lace table-cloths. Mrs. Daniger's Tea Room was one of the most popular restaurants in Southern California from 1934 until 1944. It was located upstairs on the west side of the Santora Building. Daniger's Tea Room was famous for its home cooked meals and pleasant atmosphere. It was mentioned in the June 1938 issue of Westways magazine in a feature article titled "Fine Food in California". The reopening was honored by the presence of Mrs. Daniger, who arrived in a wheelchair, looking lovely in a green print dress.

Hollywood stars frequently came to Santa Ana to visit the restaurant. Barbara Stanwyk, Andy Devine, Jack Benny, Milton Berle, Billie Burke, Charles Ruggles, Connie Haines, Lucille Ball, Gracie Allen, George Burns, Joan Davis, Rosiland Russell, Robert Young, William Holden and Alan Ladd were among those who

autographed the guest book.

Rob Richardson, Executive Aide to Supervisor Stanton, presented a congratulatory resolution to the Santora Partners and the the Orange County Historical Society. Councilman Ron May, representing the City of Santa Ana, presented a resolution from the City.

### PAINTED LADIES OF SANTA ANA

The Dr. Waffle House had some famous visitors last month. The authors of three nationally-known books about historic houses stopped by to take both exterior and interior photographs, with the possibility that they might use one or two in a future book. Elizabeth Pomada and Michael Larsen of San Francisco have written Painted Ladies, Daughters of Painted Ladies, and Painted Ladies Revisited. All three of the attractive books contain beautiful colored photographs of Victorian houses in San Francisco and other historic cities. Their new book will feature restored Victorian houses from throughout the United States. E. P. Dutton Publishing Company of New York are the publishers. The Painted Ladies Calendar 1991 will soon be available at stationery stores. It features large full-color photographs of elaborate Victorian mansions.

The house pictured to the left is the Keech-Klatt House. located at the corner of Washington and Bush Streets in the French Park Historic District. The new owners, Ron and Debbie McOuen have completely stripped all of the old paint off of the house and will soon begin to paint it in fresh new colors. One of the finest historic homes in Santa Ana, the Keech-Klatt House is a superior example of Colonial/Classical Revival architecture. It was built in 1899 by the prominent Santa Ana lawyer, E.E. Keech, Mr. Keech was a friend of Earl Stanley Gardner, the famous mystery writer


